NNDC Informing the Parish Council that the amenity verge cutting, which is 10 times per year, to the area of land at Camping Hill and the verge approaching Church Street would no longer be financed by the NNDC. They would continue to cut the verge 5 times per year as a highway safety measure. The cost for the amenity verge cutting had been estimated at £194.23 per year. The Councillors agreed that they would not pay for the amenity verge cutting for the next year. However, they agreed that the Clerk should write to Victory Housing to enquire if they would be willing to pay or make a contribution to the amenity verge cutting as the majority of the area in question was surrounded by their properties.

Councillor Jonathan Savory informed the Council that the decision for the Boundary Commission Review Report was due to be made public on the 13th February.

The N N D C website which was first developed in 2002 is being upgraded and will be available by the end of March.

Report from Councillor Derek Baxter

The market for recycled materials

The Waste & Resources Action Programme (WRAP) are fairly confident that, while market conditions are difficult, the great majority of material collected for recycling is finding a market. Reports of extensive stockpiling are not justified by the facts. There has been a significant reduction in the prices paid for recycled materials - as there has for virgin materials - which will have implications for local authority finances but even here there is evidence that prices are starting to stabilise.

Paper has borne the brunt of the downturn, however demand does still exist for newspapers and magazines, glass, organic waste and plastic bottles. WRAP are concerned by the risk that media reports will persuade significant numbers of people to stop participating in recycling services and indeed may make it difficult for local authorities to introduce necessary service improvements. This would inevitably increase the volume, and associated cost to the council tax payers, of waste sent to landfill.

Invitation to the launch of the Norfolk Climate Change Strategy

Norfolk people are responsible for significantly more CO₂ emissions per head than the national average, according to Norfolk Climate Change Strategy - Tomorrow's Norfolk, Today's Challenge - which will be launched on Friday 6th February in Norwich.

As a low-lying county with a growing population, Norfolk is particularly vulnerable to the effects of a warming climate - including sea level rises, storms, heat waves and drought. Yet the amount of CO₂ produced per person in Norfolk is 8.00 tonnes a year, well above the national average of 7.4 tonnes.

'Tomorrow's Norfolk, Today's Challenge' outlines the implications of climate change for Norfolk, identifies priorities for action to reduce CO2 emissions, and the need to adapt to unavoidable global warming. It also recognises that there may be opportunities from the development of low-carbon industries, as well as for tourism and new crops if summers are hotter and growing seasons longer.

The strategy is a key element of 'Norfolk Ambition', the county's Sustainable Community Strategy, which has set a target of an 11% reduction in carbon emissions by 2011. As major service providers, purchasers and energy users, local authorities can lead by example, and at the same time provide better value for money for tax payers. But the strategy is also aimed at the wider community, covering travel and transport, business and the economy, development and housing, and energy.

Update on refreshment of the Drainage Protocol

At the last time of reporting' in January 2008, it was evident that some District Council officers, amongst others, were not aware of the "land drainage protocol". The protocol has now been discussed and agreed by the Norfolk Resilience Forum Environmental Sub Group and at the Highways Management Liaison Group which involves all District Councils. All District Councils, the Environment Agency and the Internal Drainage Board have returned signed letters to Norfolk County Council stating that they agree with the protocol and have undertaken to ensure their staff are aware of its existence and understand each partners responsibilities.

Norfolk County Council have added the Drainage Protocol to its website and have ensured the Customer Service Centre is aware of its existence and understand its contents. Planning & Transportation Area Managers have refreshed the protocol amongst their operational staff to ensure members, Parish Councils and the public can be fully briefed on its existence and thus who they should contact for any drainage queries.

In addition the Government initiated the Pitt Report following the summer floods of 2007. The report gives 92 recommendations and central Government published their response to them on 17 December. The Pitt recommendations show that the Local Authorities would lead on 25 actions with a further 12 recommendations to be actioned through the Local resilience Forums. The County Council is studying the Government response and will report back sometime in March or April.

Issues raised covered the speed gun which has been purchased by Wells Town Council and will be used in the adjoining villages. The lack of attendance by the Community Police Liaison Officers at Parish Council Meetings was also raised by many of the Councils represented and the lack of their powers (they are unable to issue parking tickets) regarding unauthorised parking. A second meeting will be held on 9th June

NNDC - Reduction in verge cutting At the last meeting the Councillors had been informed that the amenity verge cutting, which in the past has been cut 10 times per year, to the area of land at Camping Hill and the verge approaching Church Street would no longer be financed by the NNDC. They would continue to cut the verge 5 times per year as a highway safety measure. The cost for the amenity cutting had been estimated at £194.23 per year. A private house owner at Camping Hill informed the Councillors that a contribution of £27.00 per year is paid to Victory Housing towards the cost of the verge cutting, but was unsure if everyone at Camping Hill was required to pay a similar contribution. Tree on the Knoll It appears the Cherry Tree on the Knoll has died and it was suggested that it should be replaced with a species of tree that is native to the area. A Red May or a Sweet Chestnut were put forward for consideration. It was also suggested that the soil may need to be tested to find out why the tree had died.

Village Sign Further discussion took place regarding the state of the village sign and the Councillors agreed that the village sign was now beyond repair. Mark Harrison offered to contact George Huggins from Fakenham to enquire if he would be able to quote for a new village sign at an acceptable price. It was agreed by the Councillors that they would like the new sign to be of a similar design to the old one.

Street Lights - The Clerk informed the Council that the street light on the Knoll which is very dull, and the street lights at Bridge Street and on Wells Road have been reported to the street lighting maintenance contractor.

The Minutes of the last meeting held on Monday 2nd March 2009 were read, approved and signed as a true record by the Chairman

2 Matters Arising

NNDC - Reduction in verge cutting At the last meeting the Councillors had been informed that the amenity verge cutting, which in the past has been cut 10 times per year, to the area of land at Camping Hill and the verge approaching Church Street would no longer be financed by the NNDC.

They would continue to cut the verge 5 times per year as a highway safety measure. However a private house owner at Camping Hill had informed the Councillors that a contribution of £27.00 per year is paid to Victory Housing towards the cost of the verge cutting, but was unsure if everyone at Camping Hill was required to pay a similar contribution. In order for the Clerk to investigate this matter further, the parishioner agreed to provide the Clerk with the invoice for this charge.

6 Parish Plan

Steven Bashforth informed the Councillors that the questionnaire has now been distributed. The completed questionnaires will be collected in due course. A Parishioner queried if the results of the questionnaire could be abused by those analysing the answers contained in the questionnaire? Steven Bashforth stressed that the questionnaire was purely a process used for information gathering to enable a Parish Plan to be produced. The Parish Plan is being produced by a working group made up of entirely independent representatives from the village.

Tree on the Knoll It was suggested that the tree on the Knoll which appears to have died should be replaced with either a Field Maple, a Red May or a Cherry Tree in the autumn.

Village Sign At the last meeting the state of the village sign had been discussed and the Councillors had agreed that the village sign was now beyond repair.

The Chairman and Allan ^{Curtis} ~~Tuck~~ had been to inspect a fiberglass village sign at Fring which had been made by a contact at Litcham who was known to Mr ^{Curtis} ~~Tuck~~. The price quoted for a new fiberglass sign was £300 but it was unclear if this price was just for the mould as it was thought that the painting of the sign would likely cost as much as this again if not more.

Eddy Proctor informed the Council that he had also been making some enquiries and had obtained a quote for a fiberglass village sign at a cost of £750 with an additional cost of £130 for the roof and fittings from a firm at Barton Mills, Suffolk. The only other additional cost would be the purchase of a post.

It was agreed that formal quotes would be obtained from both suppliers.

Bus Stop - Following a request from a parishioner the Clerk is investigating the cost of a bus shelter to be located at Camping Hill for eastbound traffic. To encourage people to use public transport grants are now available towards the provision of bus shelter and these would be investigated.

Adoption of Phone Box - Janey Sugden presented the Councillors with a petition requesting the Parish Council to adopt the phone box. Janey Sugden had investigated the possible costs involved and confirmed that the disconnection of the electrical supply would cost £433 plus vat. BT will make a charge of £1 ^{per} ~~per~~ ^{in total} week. If the Parish Council adopts the phone box and takes over the current electrical supply it will only cost £25 per year and there will be no standing charge.

Views sought from young people with diabetes in Norfolk

The views of young people with diabetes and their families are being sought by a working group set up to look into services for children with the condition.

The Norfolk health Overview and Scrutiny Committee is made up of 15 county and district councillors from across Norfolk. It acts as a watchdog to safeguard and promote the interests of people in the county who use health services.

The committee has set up a working group which is looking into diabetes services for young people in Norfolk. As part of their work they would like to hear about the experiences of children and young people in Norfolk who are diabetic and their families and carers.

Road surface dressing programme underway in Norfolk

Norfolk County Council's road surface dressing program for 2009 began mid-April with work starting in the Hopton area, around Ludham and to the east of Acle.

The £6.5 million surface dressing programme, carried out for the Council by May Gurney, will last for about 5 months. This work takes place every year while the weather is warmer, with the holiday areas and the main roads treated first. Where possible, work is planned away from busy main roads during peak periods, but because it is fast-moving and may be suspended during bad weather, it is hard to give motorists early warning of where the crews will be working.

Surface dressing involves laying a thin layer of bitumen and chippings on to the road to improve skid resistance for safety reasons, but also helps keep water from getting to the road structure below, which can lead to the road breaking up more quickly.

The surface dressing programme involves firstly the main A roads in Norfolk for completion by the end of June, and other routes are then completed by the end of the summer in August/September.

Spring into washable nappies and make real savings

Parents in Norfolk will be reminded that there is a real choice when it comes to nappies, with a series of talks and demonstrations to ante-natal and post-natal groups throughout April. Norfolk County Council's waste reduction team will be dispelling some myths and emphasising that using modern washable nappies can help parents save money and reduce their carbon footprint.

In Norfolk, we estimate that we are burying around one tonne of disposable nappies in landfill sites for each child, at a cost of £40 per tonne just in landfill tax. When the waste collection and disposal costs are added, it runs into hundreds of thousands of pounds per annum.

Parents are spending thousands of pounds each year buying disposable nappies - with an estimated £1000 bill to use disposable nappies for just one child, compared to up to £500 for using washable nappies.

These low levels of public spending are found across all parts of the public sector in the region, including services provided by central government, local authorities, police, schools and the health services.

Between 2002/03 and 2007/08 the East of England received around 87% of the average spending per head for England.

For 4 of those 6 years, the East of England had the lowest level of public spending per head of any region in England.

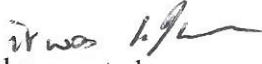
1 Minutes

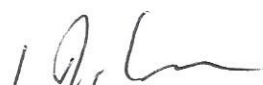

Voters last went to the polls for the County Council elections in May 2005, however turnout has been declining in recent years.

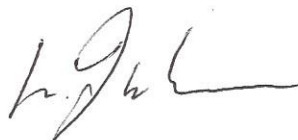

Flood Sirens

Parishes with a siren have been asked if they wish to retain the siren. It would be advisable for Parishes to request more detailed information and to meet with County Council officials to discover the detailed implications.

Smoke Alarms

Fit a working smoke alarm or risk drowning in toxic smoke is the stark message being delivered by fire and rescue services across the east of England today. It takes just two to three breaths of toxic smoke in a house fire to render you unconscious. Fit a smoke alarm, test it weekly, plan an escape route in the event of a fire. You can get a free home fire risk check from your local fire and rescue service.

Community Composting Scheme

The County Council is encouraging composting as a way to reduce waste. One advantage of the scheme is the availability of recycling credits. A 'brochure' giving full details is with the Clerk.

Electric Blankets

County Council Trading Standards Service strongly recommends electric blankets are tested. Last year more than half the blankets tested failed safety checks. Sometimes it is the age of the blanket, sometimes the way it has been stored – be safe and have the blankets checked.

Grays Arcade Wells

Following conversations with Mr Geoff Lyon I forward this update. Mr Lyon has been in discussion with Mr Chris Isaac the owner of the western half of the burnt out buildings for many months, Mr Isaac has put forward proposals which are at this moment in time deficient and require amendment before full officer support could be given. Mr Isaacs is keen to move forward however the uncertainty with the adjoining site is effectively halting progress. Compulsory purchase has been mooted however Mr Lyon considers all market led regeneration options should be exhausted, the current economic climate may thwart such an approach unless there was significant political support. Mr Lyon will continue to monitor and liaise with colleagues to get a positive result for this site.

Full Council Meeting 23 Sept 09

Planning Committee

Those of you familiar with procedure at Planning Committee meetings will know that following a planning officer outlining an application objecting or supporting members of the public are entitled to three minutes speaking time to air their views.

A new arrangement has been agreed whereby members can now ask questions back to the public speakers, a useful exercise in helping members gain the full facts prior to forming an opinion on any application.

From January 2010 for a trial period the East and West planning committees will sit together to hear planning applications.

This is partially due to increase powers of delegation to officers and a decrease in applications due to the economic climate.



War Memorial Institute

The Licensing Sub Committee will sit on Weds 9 December 2009 to consider and determine an application to vary their premises certificate. The sub committee made up of a Chairman and two Councillors will consider this application will regard to NNDC Licensing Policy and the Licensing Act 2003.

The sub committee may:

1. Grant the application
2. Grant the application subject to conditions.
3. Refuse the application.

There is a right of appeal to the decision of the sub committee to the Magistrates Court within 21 days.

Shellfish Handling Facility

The new shellfish building on the Quay will be officially opened on Friday 11 December 2009.

Recycling Centres Wells Centre is to close on Tuesdays, Wednesdays and Thursdays. Traffic will be re-directed to Hempton on these days. Hempton is now designated as a re-use Centre.

Credit Union Bank NCC has co-operated with the Norfolk Credit Union and as promised a current account can now be accessed. Loan Sharks - Continued warnings regarding loan sharks.

Post 16 Transport NCC has done a welcome u-turn Post 16 transport will continue to be subsidised. This is for travel to colleges and sixth-forms.

Coastal Access Following the Royal Assent Norfolk is to lead on developing new coastal footpaths. The Act gives authority to Natural England to create a long distance path around the coast of England.
